Directions to Mallows Bay Park 1440 Wilson Landing Road, Nanjemoy, MD 20662

From the Capital Beltway (Route 495):

- Take exit 3A Indian Head Highway/MD 210 south toward Indian Head. Continue for about 15 miles.
- Left on MD 227. Continue for about 1.3 miles.
- > Straight onto MD 224. Continue for about 2.9 miles.
- ➤ Left onto MD 225/224. Continue for about 0.3 miles
- ➤ 2nd Right onto MD 224. Continue for about 8.5 miles
- > Right onto MD 224 (Riverside Road). Continue for about 4.1 miles.
- Right onto Wilson Landing (small sign for Mallows Bay Park)

PARK in the large parking lot at the top of the hill. Portable toilets are available on site. Once you've parked, gather your things, including your compelted release and medical information forms, and walk down the hill to the river. We'll meet you right near the water. See you there!
